New Year, New Beginnings

On January 29, 2020 we honored Nancy Welch and her nine years of service to the Flinn Foundation. Welch, who retired at the end of 2019, joined the Flinn family in 2010 as the inaugural Director of the Arizona Center for Civic Leadership.



As the program director, Welch developed the Flinn-Brown seminars that have attracted more than 380 Flinn-Brown Fellows. Welch formed relationships with the Fellows, which included elected officials, policy advisors, and state agency executives, and provided opportunities to strengthen connections among Fellows with the creation of the Flinn-Brown Network.

Welch also devised the Arizona Civic Exchange, or CivEx, a four-week program about statewide policy issues that serves for many as an introduction to Flinn-Brown, and the annual All-Fellows Convention that brings together each cohort along with prominent local and national speakers.

The celebration, which was held at FABRIC in downtown Tempe, was attended by Flinn-Brown Fellows, colleagues, and friends. It also included a proclamation from Gov. Doug Ducey, presented by Flinn-Brown Fellows who serve in the Governor's Office, to honor Nancy for her work to better Arizona.



RECRUITMENT TIME!


March was focused on recruitment for the 2020 Flinn-Brown Fellowship. We developed new outreach strategies for use during the application period and ramped up our conversations with prospective candidates. Although we moved to working remotely, we determined to move forward with the 2020 application cycle. We adjusted our outreach planning to meet the new virtual environment.

RECORD YEAR IN APPLICATIONS!

After closing applications on April 27, 2020, we had a tremendous response of 129 completed applications! There is no doubt the unprecedented demand for the Fellowship was due primarily to the support of so many extraordinary Fellows in the Network, especially through promotion of the program with videos and other social media as well as the continued recruitment from their personal networks. In fact, over 75% of our applicants reported that they heard about the program through a Flinn-Brown Fellow.

THE REVIEW PROCESS

We recruited 22 Flinn-Brown Fellows to assist with the screening of applications. In teams of two, these Fellows helped us carefully consider the range of occupations, perspectives, knowledge, and experience within the cohort. As importantly, how the applicants described their desire to improve the state and their communities weighed heavily in our decision-making. The final selection task was no easy feat. As the program has gained prestige, there has been increased competition for limited interview and seminar slots. However, in an effort to accommodate this demand, we increased our typical cohort from 25 to 30.


THE "VIRTUAL" SELECTION PROCESS

COUNT US IN!

Traditionally, the state of Arizona faces obstacles in achieving a complete Census count due to a population that is diverse, expansive and often impacted by political rhetoric that magnifies these challenges. When you add a global pandemic on top of that, these challenges become even more exacerbated. by delaying all in-person outreach and operations and then cutting those operations short – Arizona's 2020 Census presented the perfect storm for an undercount. That's why it was critical for us to remain focused on driving response.

Fortunately, we knew that we could count on the Flinn-Brown Fellows to help encourage participation before the Census count concluded. Here's what we asked them to do: 1) Engage on social media from personal and organization accounts the week of 8/31- 9/6. We provided this toolkit for sample posts, PSAs, video content and even a draft script to record their own PSA! 2) Send an email to any distribution lists they have access to, and 3) Think about hosting a Census completion drive.





Year in Review: 2020 Flinn-Brown Fellows

While the postponement of Fall Academy was a disappointment to the 2020 Flinn-Brown Fellows, they did not want to wait a year to begin. They spent the fall and winter connecting with each other as well as with civic leaders engaged in politics and public policy. In October, the Fellows met virtually with Senator Kyrsten Sinema and discussed a variety of issues ranging from the 2020 election to active federal legislation. In December, Richard Stavneak, Legislative Budget Director provided the Fellows with a sneak peak of the status of the state budget for the 2021 Legislative Session. Later In the month, the Fellows spoke 1:1 virtually with City of Phoenix mayor, Kate Gallego. Again, the topics discussed spanned from transportation policy to the city's pandemic response.
